- If you haven't paid your 2020 fees, do not row, do not expose MRC to any insurance claims & or legal costs
- Please pay your membership fees before the end of December 2019, so that you can row in 2020

### **ACCESS & SECURITY**

- The front door code will be changed early in the new year 2020
- You will be informed of the new code on payment of your 2020 MRC fees
- To help maintain the security of the club, please ensure the front door is locked prior to rowing
- On departing the club, please make sure the front door is securely closed

### **PRIVATE BOAT STORAGE & INSURANCE**
